## **Position Description**

**POSITION TITLE:** Integrated Behavioral Health Clinician

**INTRODUCTION:** This position is within the Behavioral Health Division of the Yukon Flats Health Center based in Fort Yukon. The purpose of this position is to provide mental health and substance abuse counseling services to residents of all ages in the community, and provide instruction, leadership, and support services within these areas. The incumbent works under the supervision of the Behavioral Health Program Manager and is expected to work independently.

**Duties:**

- Reviews and assesses the administration and development of mental health and substance abuse services (i.e.: crisis intervention, counseling, consultations, evaluations, court-ordered assessments, prevention outreach, aftercare, referral, and involuntary commitments).
- Establishes and maintains strong relationships with other mental health and social services agencies, including, but not limited to any collaborative, partnerships or memorandums of agreement with an agency.
- Conducts or arranges immediate and follow-up crisis debriefing for behavioral health aides and community members as needed.
- Participates in providing 24-hour after-hours emergency services on weekly rotating staff schedule by responding to calls from clients in need of services.
- Provides crisis screening to determine client needs for in-patient psychiatric services or detoxification and residential substance abuse treatment services.
- Collects, compiles, analyzes, and reports program activities required by funding and governing organizations.
- Participates with the Behavioral Health Program Manager in program development,
- Participates in the development and administration of grants and contracts.
- Adheres to all policies and procedures, laws, and regulations of Federal, State, and Local Agencies, including CATG and the Yukon Flats Health Center.
- Participates in budget planning and development.
- Conducts oneself in a professional manner at all times and abides by the Federal Privacy laws regarding the confidentiality of client and co-workers.
- Engages in active cases seeking in the community to identify and address client needs.
- Performs other related duties as necessary.

**SKILLS/QUALIFICATIONS:**

- Master's Degree in Social Work, Counseling Psychology or related Science Field.
- A minimum of two (2) years work experience in social services preferred.

**OTHER:**

- Prefer candidate with experience working with or for an Indian Tribe or Tribal Organization.
- Prefer candidate with administrative and supervisory experience within the social service field.
- Under the authority of P.L. 93-638, Indian Preference shall be given to the applicant(s) who meet the minimum qualifications.
- As a Federal Contractor, CATG is required to show compliance with the Drug Free Workplace Act of 1988. CATG has initiated and maintained a Drug and Alcohol Testing Policy that includes pre-employment and random testing thereafter.
