### **TITLE: LICENSED BEHAVIORAL HEALTH CLINICIAN**

#### **POSITION SUMMARY:**

The position is located at the Yukon Flats Health Center based in Fort Yukon, Alaska. Conducts behavioral health evaluations of individuals who suffer mental disturbances or present with a wide range of emotional disturbances. Initiates the provision of services depending on the outcome of the evaluation. Provides care management services, referral and advocacy, as recommended in the assessment. The Behavioral Health Clinician works under the supervision of the CATG Clinic Director and is expected to work independently.

#### **MAJOR DUTIES AND RESPONSIBILITIES**

Provide Behavioral Health services including, but not limited to crisis intervention, counseling, consultations, evaluations, court-ordered assessments, prevention and outreach activities, aftercare, referrals, and involuntary commitments

Abide by philosophy and established policies and procedures

Establishes and maintains strong relationships with other mental health and social service agencies including, but not limited to any collaborative, partnerships or memorandums of agreement

Works with Behavioral Health Program Manager and other health leadership on program development

Work with community public schools, tribal councils, city agencies, law enforcement, and community health aides to continue the Crisis Response Team

Other duties as assigned

#### **KNOWLEDGE AND SKILLS**

Knowledge of customer service concepts and practices.

Knowledge of or ability learn resiliency or strategies to promote wellness.

Knowledge of principles and practices of direct client services.

Knowledge of community needs, resources and organizations related to behavioral health.

Knowledge of principles of social needs, problems, attitudes and behavioral health care.

Skill in written and oral communication.

Skill to work independently, with minimal supervision.

Skill in multitasking, prioritizing projects, meeting deadlines, and maintains strict confidentiality.

Skill in skill in public speaking and giving oral presentations.

Sill in preparing clear, accurate and effective written/oral reports, correspondence and other written materials.

**MINIMUM EDUCATION QUALIFICATION**

Master’s Degree in Social Work/ counseling, Psychology, or Nursing with a specialty in Mental Health.

**MINIMUM EXPERIENCE QUALIFICATION**

Non-Supervisory- Two (2) years’ experience providing various behavioral health direct services performed at a satisfactory level. An equivalent combination and/or training may be substituted for experience.

**MINIMUM CERTIFICATION QUALIFICATION**

State of Alaska licensure required.

**ADDITIONAL REQUIREMENTS**

Ability and willingness to travel in small aircraft to villages within the Council of Athabascan Tribal Governments service area

**OTHER:**

Candidate with experience working with or for an Indian Tribe or Tribal Organization, desired but not required.

Under the authority of P.L. 93-638, Indian Preference shall be given to the applicant(s) who meet the minimum qualifications.
